- We retain ownership of the system and enter into a power supply agreement with you to sell power at a price providing a material saving for a term of 25 years.
- You pay a lower rate per unit of solar electricity that you consume

ON-GOING OBLIGATIONS

We monitor, maintain and insure the system for the life of the project to ensure optimum performance. Our interests are aligned in that the more power that is generated, the more income we receive from the sale of the power, and the greater savings are achieved.

At the end of the term, ownership of the equipment transfers to the building owner, or the owner can elect to extend the term of the agreement and we will remove the equipment at the end of the extended term.

Solar panels can last for up to 40 years, which means there is the potential for power for an additional 15 years

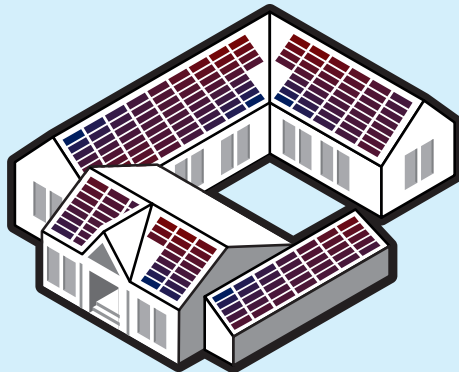

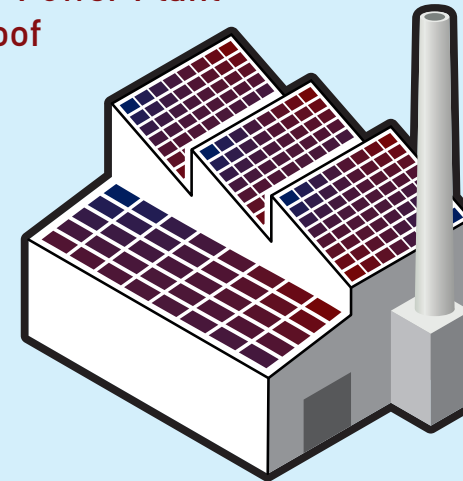

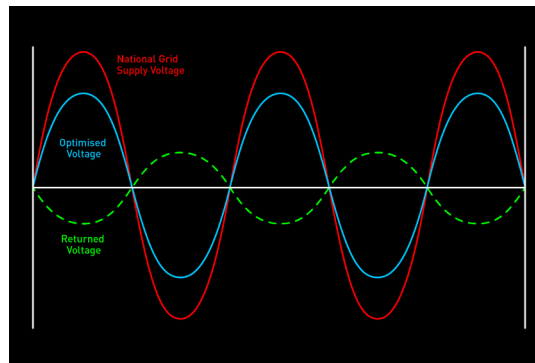

Why are we all paying for Wasted Energy?

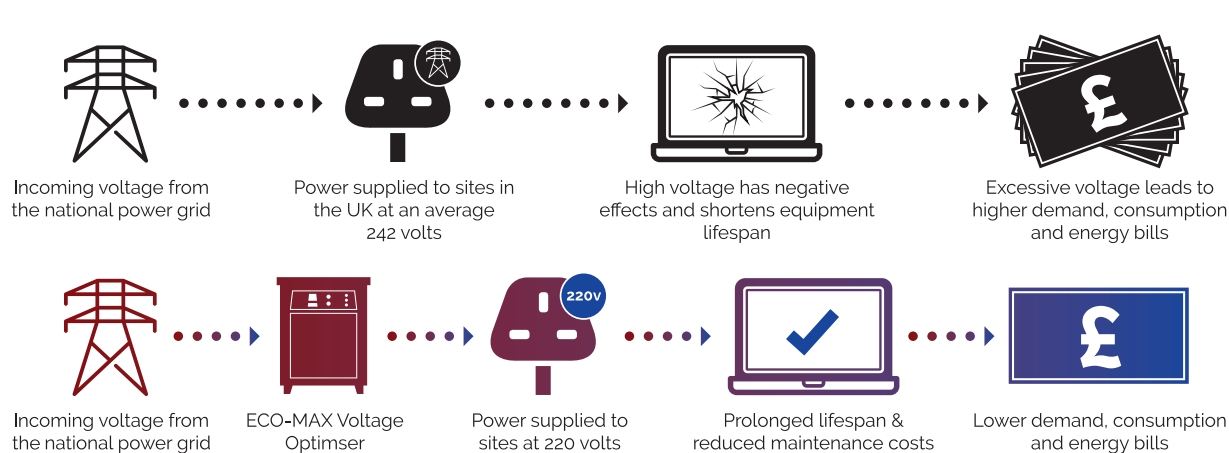
European harmonisation means our equipment works efficiently at around 220v. Supplying over this voltage is wasting energy.

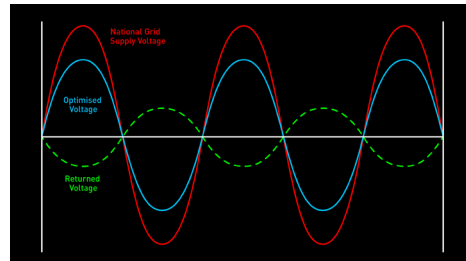
