Quotations & Orders

A confirmation will be sent to you for each order and this represents our acceptance of the order. We reserve the right not to accept any order and you will be informed if this is the case. Our quotations are made in good faith. However, we accept no liability for changes in material availability, material pricing, or any error or omission made by us in preparing our quotation.

Delivery

Your order confirmation will specify our expected delivery date and we will make an honest and sincere effort to meet the planned delivery date. However delivery or despatch dates cannot be guaranteed and we can not accept any liability arising either from early or from late delivery.

Order Amendments & Cancellations

You may request to change, cancel, vary or put on hold any or all orders that have been placed with us. We reserve the right to invoice you for all costs, charges and expenses incurred as a result of the amendment or cancellation. In addition, we reserve the right to charge an order amendment/cancellation fee of £50.

Drawings, Tolerances, Manufacturing Methods & Construction Details

Where drawings do not specify a manufacturing method or specific construction details, we reserve the right to manufacture the goods to suit our production processes.

Notwithstanding any tolerances specified on a drawing, all goods manufactured with CNC equipment are subject to the accuracy limit of the machine used. Goods manufactured with line bending, drape forming, or any other second or manual operations are subject to the reasonable accuracy limits inherent in the relevant processes.

Where customers supply a computer-generated file for direct loading into a CNC machine, due care will be taken to ensure that the file will run as anticipated. we will not, however, be liable for mistakes, errors or processing problems inherent in or caused by the customer supplied file.

Fitness for Purpose

All goods manufactured by us are to customers' own specifications. It is the customers' responsibility to ensure that the materials used, the manufacturing processes, and the design of the goods are all suitable for the contemplated application and fit for purpose. Any advice or technical assistance which we may give with regard to installation, use, or performance of goods supplied by us must be accepted as given in good faith and to the best of our knowledge and skill but without any liability on our behalf.

Warranty & Time Limit For Raising Disputes

All orders are inspected before despatch. Production batches are inspected using an ISO 9001 approved sampling process. Should any product prove to be defective owing to faulty material or bad workmanship, it will be replaced free of charge provided it is returned to us within fourteen days after the date of despatch. Any liability for consequential losses is excluded.

Damages and Shortages

All claims for damages or shortages must be made within seven days of receipt of goods.

Credit Accounts & Credit Account Settlement

All invoices are due thirty days of invoice date. Terms are strictly nett. Invoices must be paid either by bank transfer into our account or by cheque to the address shown on the invoice. Payment receipts will not be issued unless specifically requested. We reserve the right to set credit limits, increase, decrease or withdraw credit facilities at any time without advance notice.

Interest Charges for Late Settlement

In accordance with The Late Payment of Commercial Debts (Interest) Act 1998 and the Late Payment of Commercial Debt Regulations 2002 we reserve the right to charge interest on late settlement at the legally specified rate of 8% above the Bank of England reference rate. We also reserve the right to compensation for debt recovery costs in accordance with the legislation that is in force.

Value Added Tax (VAT)

Prices exclude VAT. The rate of VAT charged is the rate in force at the tax point.

Force Majeure

In no circumstances will we be liable for any breach of contract due to lockouts, strikes, industrial disputes, shortage of materials, delays in transit, accidents, unforeseen hindrances or any cause outside our control.

Ownership of Goods

Ownership on the goods or products shall not pass to the customer until full payment is received by us, and we retain the right to enter upon any property of the customer where goods are standing and to retake possession thereof.

These conditions are the Contract and shall be subject to and construed in accordance with English laws.
