You will receive your BEKassure guarantee when the fencing installation is completed. The auditor will work in conjunction with the PRO-net contractor to ensure first class installation. BEKassure guarantees are available for Betafence complete panel and post systems.

Licences are only awarded once contractors have proved they comply with the PRO-net Chartered or Licensed Contractor schemes.

Chartered Contractors have achieved the highest level of qualification within PRO-net. To achieve this status they have to pass the most stringent evaluation of their competence and commit to a programme of continuous improvement, which is measured continually against agreed performance indicators.

What does my guarantee cover?

A summary of our terms and conditions:

Your obligations

Betafence Limited must approve the conditions of use for its fencing and fence systems should be relevant to application and relative to security level. Should these change during the life of the BEKassure guarantee, then we must be informed so that any effects on the cover can be assessed. In some circumstances, such changes of use may invalidate the guarantee. The owner also has a responsibility to exercise a duty of care, covering maintenance and repair during the term of the guarantee. Full details are contained in the BEKassure guarantee document.

Claims conditions

- All claims must be made in writing to Betafence, detailing the extent of the damage to the Works Guaranteed and estimated repair costs. Failure to notify us immediately after becoming aware of the damage may invalidate your policy.
- 2. You will carry out and permit any reasonable action that may avoid a claim or prevent further damage.
- 3. No works should commence until the damage has been inspected by the independent auditor.
- 4. You are obliged to have repairs carried out within an agreed time limit by a licensed PRO-net contractor.

Your duty of care

You should ensure that any damage, regardless of how it occurs, is repaired immediately. All repairs, permanent or temporary, must be carried out by a licensed PRO-net contractor. Moving parts relating to gates should be maintained at regular intervals. Failure to perform this duty of care may invalidate any claim.

Exclusions

1. Any claims in respect of injury, death, disease, illness or loss, damage to any material property (other than the Works Guaranteed) or any financial or consequential loss or damage of any kind or description arising from the carrying out of the Works Guaranteed or any subsequent repair work arising from the client or any other party.


- 2. Damage to the Works Guaranteed due to or arising from:
 - a) Use of the works in a manner outside the parameters for which they were originally designed.
 - b) Normal wear, tear and ageing or failure to fulfil the duty of care.
 - c) Poor or faulty maintenance.
 - d) The underlying ground or sub-base of the works, which do not form part of the Works Guaranteed.
 - e) Shocks, impacts or friction damage that the fence was not initially designed to withstand.
 - f) Chemicals, steam, liquids or materials unless the fence has been initially designed to withstand their actions and has been agreed by the independent auditor. The permanent exposure to chemical or mechanical destructive elements such as dust, smoke, toxic materials and vehicle movements, except if the scope of the guarantee is in respect of the permanent effects of these elements.
 - g) Fire, lightning, explosion, earthquake, subsidence, heave or collapse (other than where such subsidence, heavy or collapse is solely in respect of Works Guaranteed and not to any other supporting or surrounding property), storm, flood, subterranean fire, changes in the water table, rising humidity or any other external force or interval that the Works Guaranteed were not designed to withstand.
- 3. Damage to any products, systems or works that have not been supplied or installed by Betafence and do not form part of the Works Guaranteed.
- 4. Damage arising directly from any of the qualifications or exclusions contained in the Guarantee Certificate following the final report of the independent auditor.
- 5. Damage to the Works Guaranteed by the wilful or intentional actions of the client or any other third party.
